

## Official Contest Rules – polyonyx+® Flooring Giveaway

1. **How to Enter:** To enter, visit [www.polyonyx.net/contest](http://www.polyonyx.net/contest) to fill out an entry form and upload your photos (maximum 5 photos). Limit one entry per Venue. The entry must fulfill all Contest requirements, as specified, to be eligible to win. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Productions Unlimited, Inc.
2. **Eligibility:** The Contest is open to any Venue in the contiguous United States. You must be 21 years of age or older, and an official representative of the Venue in order to submit an entry. No purchase necessary. A purchase does not increase the chances of winning.
